Entry requirements Dubai

Swiss citizens need a passport that is valid for at least six months beyond the date of entry. On arrival, a free visa will be issued at Dubai airport on presentation of travel documents and passport.

Foreign nationals but resident in Switzerland should provide on their own the necessary documents for entry into Dubai.

Journey to and from the seminar

Participants are responsible for organising their arrival and departure to/from the seminar hotel and for obtaining all necessary travel documents. All transfers, accommodation and meals during the seminar (from 9th to 11th Oct.) will be provided by the organiser.

Participation fee

The seminar fee of CHF 1,850 includes a 2-night stay (October 9th to October 11th, 2022) at Le Royal Meridien Hotel, as well as transfers, food and beverages during these two days (breakfast included). Dinner on Sunday evening, 9th Oct., is not included. Participants are responsible for their own travel expenses, all additional services at the hotel and the use of the minibar.
